1. Subcommittee 2 by Dr Tomohiro Matsuda

- 1.1. Cancer control analysis
 - Background
 - Grasp current status of cancer control in Asian countries
 - Based on current situation in each country, draft of Agenda will be divided into three periods
 - · Relation to other studies
 - ANCCA Project to develop NCC Program (NCCP)
 - Outline of the Plan
 - Support of Tata Memorial Hospital in India
 - Survey detailed survey of entire country
 - Standard Setting
 - Analysis of survey results
 - 18 countries developed explicit control measures, 2 do not have NCCP including Singapore and Nepal, but is in the midst of developing NCCP
 - However not all 18 countries with NCCP have the support to implement and practise the NCCP fully, only 7 countries have systems set up and support structure.
 - Follow up actions –evaluation scale and quantification of NCCP implementation progress of each country. Currently 8 items

 - 1.2. Cancer Registry Program in Nepal
 - · Background information of Nepal
 - Cancer problem
 - o There is no incidence or prevalence data in Nepal, there is only one study done in 1994
 - Cancer incidence from ANCCA studies
 - o 80.9 relatively low as compared to other Asian Countries



- Shared on Nepal Cancer Registry (2003 to 2012)
 - o A total of 56, 000 cancers cases were registered
 - Limitations Delay in getting the record, most data are incomplete, lack of medical record staffs, lack of budget
- Challenges of cancer control program
 - High cost of treatment, lack of insurance, lack of knowledge and awareness, unavailability of treatment options, lack of trained personnel, lack of diagnostic facilities, lack of tobacco control
- Question
 - Prof William, even if Nepal has incomplete population data, do they track and document cause of death in Nepal. Dr Kishore replied there is but again it is not comprehensive and may be difficult to track due to limitations.
 - Prof William suggested to have a snapshot of cancer profiles for each country


