1) Update on SC 4 – Cancer Registries – Dr Wei Wenqiang

Dr Wenqiang presented the differences among laws and regulations in the Asia-Pacific region and his plan to send a questionnaire to ANCCA members. Dr Matsuda highlighted that an alignment should be obtained among members on the staging system (such as CIS databook or any detailed procedure for each country). Such sharing of information would be useful for the countries who do not have such system to start implementing it. Dr Babu also raised the fact that some countries have cancer registry data only in their own language.

2) Update on SC 6 – Clinical trials and research – IRCWeb introduction – Dr Yoichi Osato

Dr Osato presented the “ICRWeb” training project. This training project, available for free, a National Cancer Center Japan’s project allows anyone to becoming an expert in clinical research and obtain a certificate of completion if the courses are completed. 4) Update on SC 5 Education and Training

5) Update from C/CAN: C/Can shared a project currently executing to develop e-learning course on oncology in primary health care for both adult and pediatric, in collaboration with the Catalan Institute of Oncology and pediatric cancer centre in Barcelona. The objective is to train the primary health care professionals on the early signs and symptoms of common cancers, management for minor symptoms and referral for early diagnosis and treatment complications. These courses will not hosted by C/Can, instead these will be transferred to the e-learning platform of host institutions in C/Can cities and partners. The adult course is now testing to transfer to the e-learning platform of host institutions in C/Can cities and the pediatrics course is under development.

6) Other management topics

6.1 Prof William and Taufiq (SG) were pleased to inform members that the dates for High Level meeting will organised by SG during the week of 30 Oct to 4 Nov 2023 in the new NCC-SG building. The venue will be provided by NCC-SG. Accommodations and transportation should be borne by each country, and an hybrid-venue was also proposed for those who could not afford to join (e.g. specially from low middle income countries). One or two days were suggested. Dr Matsuda suggested that to make sure as many Directors can join, the HL meeting itself should be planned around mid-day, and the Scientific Conference or other gathering could be planned before and/or after to allow those who can stay overnight to discuss further about conference topics among others.
